The bill concerning Forest-street, in Baltimore-town, in Baltimore county, was read the second time by especial order, passed, and sent to the senate, with the resolution in favour of Margaret Max-

well, by the clerk.

A petition from Jesse Locke, of Saint-Mary's county, praying to be released from the costs of a profecution inflituted against him, and of which he was acquitted by jury trial, was preferred, read, and referred to the committee of grievances and courts of justice, to confider and report thereon.

A petition from Duncan Shipley, stating, that he intermarried with Cassandra Chew, and praying

that some person may be authorised to inquire into the right of his wife to certain lands originally leased by lord Baltimore, and that his right may be confirmed, was preferred, read, and referred to Mr. Duvall, Mr. Ewing and Mr. Sprigg, to confider and report thereon.

A petition from William Charles Neil, praying that he may be authorifed to remove certain negroes into this state which were removed from this to the Delaware state, was preferred, read, and

referred to Mr. Duvall, Mr. J. Ringgold and Mr. Sprigg, to confider and report thereon.

A petition from Kinvin Wroth, junior, of Kent county, praying to be released from a purchase of confiscated property made of the state, upon surrendering the property purchased, was preserted, read, and referred to Mr. Tilghman, Mr. Duvall and Mr. Kerr, to consider and report thereon. Petitions from Charles Franklin, of Baltimore county, and Joshua Dorsey, of Henry, of Anne-

Arundel county, praying acts of infolvency, were preferred, read, and referred to the committee on

petitions of a fimilar nature.

On motion, Leave given to bring in an additional supplement to the act for marking and bounding of lands. Ordered, That Mr. Tilghman, Mr. Kerr, Mr. Duvall, Mr. Hollingsworth and Mr. Ridgely, of Wm. be a committee to prepare and bring in the fame.

A petition from Benjamin Preston, of Harford county, praying that he may be authorised to sell the real estate of a certain William Cole, in order to indemnify himself as a security, was preferred, read, and referred to Mr. Jarrett, Mr. Ridgely and Mr. Duvall, to consider and report thereon.

A petition from fundry inhabitants of Dorchester and Talbot counties, praying that the road from Cambridge to Easton may be condemned as a public-road, was preferred, read, and referred to Mr. Campbell, Mr. Eccleston, Mr. Goldsborough, Mr. Tilghman and Mr. Hutchings, to consider and report thereon.

The bill to lettle and afcertain the falary of members of the council for the enfuing year, was read

the second time, agreeably to the order of the day, passed, and sent to the senate by the clerk.
