Mr. M^cMechen, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act to enable John M^cKim and John Brown, of Baltimore county, to convey certain land to the uses therein mentioned; which was read the first time and ordered to lie on the table.

Mr. Johnson, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, A further supplement to the act to encourage the destroying of wolves; which was read the first and second time by especial order, passed, and sent to the senate by the clerk.

A petition from John Robertson, of Charles county, praying to be satisfied the amount of a debt due from James Jamieson, whose property was confiscated and sold, was preferred, read, and referred to Mr. Harwood, Mr. Campbell, Mr. Chapman, Mr. Sprigg and Mr. Duvall, to consider and report thereon.

A petition from Edward Lloyd Wailes, late sheriff of Prince-George's county, praying compensation for fees arising on the imprisonment of insolvent debtors, was preferred, read, and referred to Mr. Oneale, Mr. Johnson and Mr. Hawkins, to consider and report thereon.

A memorial from William Fitzhugh, praying compensation for losses sustained during the late war, was preferred, read, and referred to Mr. Oneale, Mr. Kerr, Mr. Chapman and Mr. Loockerman, to consider and report thereon.

A petition from Tubman Lowes, of Somerset county, praying compensation for injuries done to his property during the late war, was preferred, read, and referred to Mr. Cox, Mr. Duvall and Mr. Oneale, to consider and report thereon.

A petition from Wendel Keller, of Baltimore-town, praying an act of insolvency, was preferred, read, and referred to the committee appointed on petitions of a similar nature.

On motion, Leave given to bring in a bill to prevent swine from running at large in the town of Cumberland, in Allegany county. ORDERED, That Mr. Bayard, Mr. Tomlinson and Mr. Johnson, be a committee to prepare and bring in the same.
