Mr. Duvall, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act for vesting in Thomas Cockey Deye, and his heirs, all the right and interest of the state of Mary-land in and to a tract of land called Lancastar; which was read the first time and ordered to lie on

the table.

The supplement to an act, entitled, An act for the relief of the poor in Dorchester and Somerset

counties, was read the second time, and passed,
