

SUNDAY, December 29, 1793.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read.

The clerk of the senate delivers the paper bills No. 45, 53, 65, 66, 67, 68, 70, 71, 72, 73, 74, 76 and 77, severally endorsed; "By the senate, December 28, 1793: The engrossed bill whereof this is the original read and assented to.

Mr. Contee appeared in the house.

William Tilghman and John Eager Howard, Esquires, from the senate, acquaint Mr. Speaker that the governor is waiting in the senate to sign and seal the engrossed bills, and requests the attendance of this house for that purpose.

Mr. Speaker left the chair, and, attended by the members of this house, went to the senate, and there presented the following engrossed bills to the governor, who signed the same, and affixed the great seal thereto, in the presence of both houses.

- No. 1. An act for the benefit of Joseph Johnson, of Charles county.
- No. 2. An act to settle and ascertain the salary of members of the council for the ensuing year.
- No. 3. An act to alter and change the name of George Washington Eyers to George Washington Nicholson.
- No. 4. An act for valuing the lot or lots of ground in Upper-Marlborough, in Prince-George's county, on which the inspecting houses stand, and for paying the proprietor the value thereof.
- No. 5. An act to prevent sheep and swine from going at large in the town of Cumberland, in Allegany county.
- No. 6. An act concerning Temple-street, in Baltimore-town, in Baltimore county.
- No. 7. An act to establish the road from the Turkey Foot road towards Braddock's road as a public road, and for other purposes therein mentioned.
- No. 8. An act to authorize the justices of Dorchester county to assess and levy a sum of money on the inhabitants of said county for the purpose therein mentioned.
- No. 9. A Supplement to the act, entitled, An act to establish a market in Elizabeth-town, in Washington county, and for the regulation of the same.
- No. 11. A Bill, entitled, An act for the relief of Walter Smith.
- No. 12. An act to aid the proceedings of Allegany county court, and for the adjournment of said court.
- No. 13. An act to open a road through part of Frederick and Baltimore counties to Lawrence and Dorsey's mills on Patapsco Falls.
- No. 14. An act to enable the inhabitants of Saint John's parish, lying in Queen-Anne's and Caroline counties, to elect vestrymen and churchwardens for said parish.
- No. 15. An act further extending the exclusive privilege granted to Gabriel Peterfon Vanhorn and Robert Hodgson, by certain acts of this state, to keep and run stage carriages.
- No. 16. An act for altering the time of holding the orphans court in Allegany county.
- No. 17. An act for building a court-house and gaol for Allegany county, at the town of Cumberland.
- No. 18. An act to establish the road leading from Crooked Run, in Worcester county, to Saint-Martin's Landing, as a public road.
- No. 19. An act to increase the allowance to jurymen of the general court, and the several county courts, in this state.
- No. 20. An act to confirm the title of certain lots of ground to the society of people called Quakers, in Baltimore-town, whereon is their meeting-house and burying-ground.
- No. 21. A Supplement to an act, entitled, An act for the inspection of salted provisions exported and imported from and to the town of George-town, in Montgomery county.
- No. 22. A Supplement to an act, entitled, An act to establish a market at the market-house in Chester-town, in Kent county, and for the regulation of the said market.
- No. 23. An act to continue an act, entitled, An act for the better administration of justice in the several counties of this state, and the supplementary acts thereto.
- No. 24. A Supplement to an act, entitled, An act for the relief of the poor in Dorchester and Somerset counties.
- No. 25. An act to lay out a road from Francis Snowden's mill, in Baltimore county, to the great falls of Patapsco, at or near Solomon Allen's mill, where the great road crosses said falls, and to lay out a road from the said Snowden's mill to intersect the old road leading from Baltimore to Liberty-town.
- No. 26. An act to extend to certain foreigners the benefit of an act passed November session, one thousand seven hundred and ninety-two, entitled, An act for the relief of certain foreigners who have settled within this state, further supplementary to the act for naturalization.
- No. 27. An act to revive and aid the proceedings of the orphans court of Montgomery county.
- No. 28. An act for vesting in Thomas Cockey Deye, and his heirs, all the right and interest of the state of Maryland in and to a tract of land called Lancaster.
- No. 29. An act for the relief of William Benson, and for other purposes.
- No. 30. An act to establish a bank in the district of Columbia.
- No. 31. An act to empower John Seney and Robert Seney, administrators of Jonathan Seney, to collect the balances due to Jonathan Seney as sheriff and collector of Queen-Anne's county.
- No. 32. An act to lay off and open two roads in Allegany county.
- No. 33. An act for the relief of Elam Bailey, of Baltimore county.
- No. 34. An act to define and ascertain the powers of the governor on the subject therein mentioned.
- No. 35. An act respecting the stealing and counterfeiting of bank notes or checks.
- No. 36. An act to repeal, conditionally, an act, entitled, An act for the relief of William Whetcroft, of the city of Annapolis, passed at November session, seventeen hundred and seventy-nine.
- No. 37. An act to establish the right of a lot called Charity Lot, in East Nottingham, Cecil county, to trustees, in trust for the inhabitants of said township for the use of a school.
