The engrossed bill No. 72, was read and assented to, and sent to the senate, with the paper bill thereof, by the clerk.

The clerk of the senate delivers the paper bills No. 71 and 72, severally endorsed; "By the senate, December 27, 1794: The engrossed bill whereof this is the original read and assented to.

Charles Carroll, of Carrollton, and John Eager Howard, Esquires, from the senate, acquaint Mr. Speaker that the governor is waiting in the senate to sign and seal the engrossed bills, and requests the attendance of this house for that purpose.

Mr. Speaker left the chair, and, attended by the members of this house, went to the senate, and there presented the following engrossed bills to the governor, who signed the same, and affixed the great seal thereto, in the presence of both houses.

- No. 1. An act to settle and ascertain the salary of members of the council for the ensuing year.
- No. 2. An act to revive and aid the proceedings of the orphans court of Queen-Anne's county.
- No. 3. An act for annulling the marriage of Schoolfield Parker, of Worcester county, and Sarah his wife.
- No. 4. An act for building a new prison in Worcester county.
- No. 5. An act to empower Micajah Merryman, father and guardian of Sarah Merryman, Moses Merryman, Eleanor Merryman, Mary Merryman and Micajah Merryman, infants, to demise the real estate therein mentioned.
- No. 6. A Supplement to an act, entitled, An act respecting the continuance of civil suits in the general and county courts.
- No. 7. An act to confirm the proceedings of Caroline county levy court, and to extend the time for the late collector of said county to complete his collections and receive the arrearages due therein.
- No. 8. An act to authorize and empower the associate justices of Caroline county court to call a court before the time to which the same stands adjourned.
- No. 9. An act for the establishment of a market for the sale of live stock at Westminster-town, in Frederick county.
- No. 10. An act to alter the time of holding the levy courts in the several counties therein mentioned.
- No. 11. An act to compel the attendance of the members of the general assembly.

- No. 20. An act to form a new parish, by the name of Washington parish, to include the city of Washington and George-town, on Patowmack.
- No. 21. An act to enable Legh Master, of Frederick county, to devise certain estates therein mentioned.
- No. 22. An act to authorize and empower the levy court of Montgomery county to assess and levy annually a sum of money for the purposes therein mentioned.

- No. 25. An act relating to the clerks, sheriffs and registers of wills, in the several counties therein named.
