Johnson, Mr. Cresap and Mr. Beall, to consider and report thereon.

The bill to empower John C. Beatty to collect the balances due him as sheriff and collector of Allegany county, was read the second time by especial order, passed, and sent to the senate by the

clerk.

Mr. Henry James Carroll, a delegate returned for Somerset county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, and taking the oath to support the constitution of the United States, took his seat in the house.
