First page, 17th line, strike out the words "before any magistrate of Worcester or Somerset counties, as the case may require," and insert "by action of debt in the county court of the county in which the offence may have been committed." Second page, 3d line, after the word, "committed" insert, "to be applied towards the improvement of the navigation of the said creek."

Which were read the first and second time, agreed to, and the bill ordered to be engrossed.

The bill for making an addition to the town of Havre-de-Grace, and to improve the navigation of the river Susquehanna, and for other purposes, was read the second time by especial order, passed, and fent to the fenate by the clerk.

Mr. Oneale, from the committee, brings in and delivers to Mr. Speaker a supplement to an act, entitled, An act to establish a bank in the district of Columbia; which was read the first time and

ordered to lie on the table.

Mr. Whittington, from the committee, brings in and delivers to Mr. Speaker a bill, entitled, An act to establish the road leading from William Davis's blacksmith's shop to the sea side, and also the road leading from the public road near John White's tavern to a place called Locust Landing, in Worcester county, as public roads; which was read the first time and ordered to lie on the table.

Whereas it is represented to this general assembly, that Cokesbury college, in the town of Abingdon, in Harford county, hath lately been consumed by fire, and that some malicious persons are supposed to have wickedly and wilfully set fire to the same, RESOLVED, That the governor and council be and they are hereby authorised and requested to offer such reward as they shall think proper, not exceeding two hundred dollars, payable out of the public treafury, for the discovery of the person or persons by whom the said offence may have been committed, provided that the said person or persons be brought to justice.

The supplement to the act, entitled, An act to establish a bank in the district of Columbia, was

read the second time by especial order and passed.
