Second page, 3d line, strike out the word "April" and insert the word "June." Same page, strike out from the beginning of the last clause to the end of the 11th line of the 5th page inclusive. Fifth page, strike out the whole of the last clause. Sixth page A, 12th line, after the word "payment" insert "in the first place of all expences incurred in conducting the said lottery, and the payment of all fortunate adventurers therein, and for the saithful payment." Fourteenth line, same page, strike out "Harford county" and insert "the general." After the end of the clause in the 6th page A, strike out all the residue of the bill, and insert "And be it enacted, That the product of the said lottery, after first paying the expences of drawing the same and the product and produce of the faid lottery, after first paying the expences of drawing the same, and the fortunate adventurers, shall be paid, within four months after the drawing of the said lottery, into the hands of Ephraim Blaine, Robert Whitehill and John Bratton, of Pennsylvania, and George Gale and Samuel Hughes, of the state of Maryland, who shall give bond to the state of Maryland, in the penalty of forty thousand pounds current money, before they shall receive the same, before the chief judge, or one of the affociate justices, of Harford county, whose duty it shall be to lodge the faid bond in the office of the general court of the western shore, to be there recorded and safely kept, and which bond shall be conditioned to be void if the said Ephraim Blaine, Robert Whitehill, John Bratton, George Gale and Samuel Hughes, or a majority of them, shall faithfully apply the said money towards the opening the navigation of the bed of the said river, in such manner as they shall think most expedient, and that no part thereof shall be applied to the opening or improving the canal of the proprietors of the Susquehanna canal."

The bill to incorporate an infurance company in Baltimore-town, endorsed; "By the senate, "December 19, 1795: Upon reconsideration will pass with the proposed amendments.

Second page, 12th and 13th lines, strike out "within fisteen days after the passage of this act," and insert "on or before the second Monday in February next." Strike out from the word "residue" in the last line of the second page to the end of the line, and insert "on or before the second Monday in February, seventeen hundred and ninety-seven." Page 3, after the word "in" in the 10th line, add "provided, that if any person shall neglect or resule to pay the same one third part on or before the said first Monday of February, he shall cease to be a member of the said corporation, and his share or shares shall and may be disposed of by the directors to be chosen as herein after directed, to such person or persons as may apply for the same." Page 3, strike out the proviso. Same page, 15th line, after the word "that" insert "out of," and after the word "aforesaid" in the same line, insert "the sum of twenty thousand dollars." At the end of the 17th line add "and the residue of the said capital stock shall be invested in the stock of the bank of the United States, or of the banks in this state, or in the public debt of the United States." Fourth page, at the end of the 7th line, insert "And be it enacted, That the said directors shall from time to time apply all sums received by them for premiums to the payment of their losses in the first inflance, and to make up the amount of their original capital where it shall sustain any diminution by fach losses, and after replacing their original capital as aforesaid, shall make such dividend of the residue among the said stockholders as they in their discretion shall think expedient." Sixth page, 2d line from the bottom, strike out the word "twenty" and insert "nine."
