By order, RESOLVED, That Valentine Brother, Esquire, of Frederick-town, be and he is hereby authorised to sell and dispose of, under the direction of the governor and council, on the best possible terms, for the benefit of the state, all gunpowder and brimstone now in the magazine at Frederick, and all fuch arms and accourrements in the armoury at Frederick as are unfit for use without previous repairs, and the faid Valentine Brother shall be entitled to a commission of three per cent: on the amount of such sales, as a compensation for his services; provided, that before he shall proceed to make any fale as aforefaid, he shall give bond to the state, with such security as the governor and council shall approve, conditioned for the faithful discharge of the trust bereky committed to him, and for the payment into the treasury of the western shore of all monies by him received in virtue thereof, within three months next after such receipts, after deducting the amount of his said com-

mustions, which shall be ascertained by the auditor-general. RESOLVED, That in case it shall be deemed necessary to transport the said powder to Baltimore-town, or other place, for sale, or to surnish casks for the purpose of containing and securing the fame, the governor and council shall be authorised to draw upon the treasury in favour of the said Valentine Brother, for such sum of money as will enable him to procure the said casks, and to effect the faid transportation, an account of the application of which money shall be rendered by the said Valentine Brother to the auditor-general, and the surplus unexpended, if any, shall be paid by him

into the treasury, and his aforesaid bond shall be liable therefor.
