GENTLEMEN OF THE SENATE,
THE recovery of the bank stock due to us in England is an object of serious consequence to the state; we have thought an inquiry into the present situation of our claim indispensably necessary, and propose a conference with your house on the subject, and have nominated Mr. Robert Smith, Mr. Philip B. Key, Mr. Henry H. Chapman, Ar. Allen B. Duckett and Mr. David M'Mechen, conferrees to meet any gentlemen you may think proper to appoint for that purpose, in order that satisfactory information, if practicable, may be laid before the legislature.
