hath paid away the sum of £. 22 3 9, for which payment have been produced to your committee the necessary voucher and receipt, and that there still remains in the treasury the sum of £. 3300.44.

It also appears to your committee, that William Marbury, Esquire, agent, has, in virtue of an act entitled, An act to appoint an agent for the year one thousand seven hundred and ninety-fix, taken bonds to the amount of £. 9099 4 11, which said bonds are deposited in the treasury-office, and that the said agent has transferred to the trustee the sum of 62424 dollars 91 cents 6 per cent. stock,

Your committee beg leave further to report, that it appears by an act, entitled, An act to effablish funds to secure the payment of the state debt within fix years, and for the punctual payment of the annual interest thereon, passed November session, 1784, certain sunds were pledged for the redemo-tion of the emissions of June, 1780, which were finally to be redeemed in the year 1790; that by an act, entitled, An act respecting the debtors and creditors of this state, passed November session, 1789, the whole sunds of the state were consolidated and made payable in species, or certificates slued by this state, by which means the said emissions have not been redeemed; and it appearing to your committee, that the faith of the state is pledged for the redemption of faid emissions, and it also appearing to your committee, that there still remains of those emissions in circulation the fum of L. 13756 0 0 principal and interest, they are of an opinion the legislature ought to provide funds adequate for the redemption thereof, with the accruing interest thereon.

The committee further report, that under an act of the legislature, passed November session, 1785, vesting certain powers in the governor and council, a loan of specie was procured, bearing an interest of eight per centum per annum, to the amount of £. 2468 2 0; that there appears still due of the principal of the said debt the sum of £. 2167 0.0. Your committee suggest the propriety of passing a law, limitting the time for the redemption of the said debt, and providing funds competent

Which was read.

All which is submitted to the honourable house.
