Your committee further beg leave to report, that it appears from the treasurer's books, that the sum of f. 268 10 6 stands as a balance against Thomas O'Bryon, sheriff of Queen-Anne's county, for sines, forfeitures and amerciaments, retailers, ordinary and pedlers licences, received by him in the year 1792; that several sums of money were afterwards paid by the suid Thomas O'Bryon, and applied by the treat furer to the discharge of balances due from him for the year 1793 and 1794, which your committee conceive ought in justice to have been applied to the discharge of the balances due for the year 1792, Your committee further state, that the aforesaid Thomas O'Bryon is dead, and there is not the slightest probability that any part of this money can be recovered from his estate, but the whole, together with other sums to a very considerable amount, must be paid by his securities. Under these circumstance,

therefore, your committee submit the following resolution, viz.

Whereas it appears to this general assembly, that the sum of £.268 10 6 stands on the treasurers books as a balance against Thomas O'Bryon, a former sherist of Queen-Anne's county, for-sines, forfeitures and amerciaments, retailers, ordinary and pedlers licences, received by him in the year 1792, and that the faid Thomas O'Bryon is dead, and his securities are likely to suffer very materially by reason of the insufficiency of his estate to discharge his debts; therefore, RESOLVED, That Robert Waters, William Diamond, two of the securities of the said Thomas O'Bryon for the year 1792, be and they are hereby authorised to discharge the said balance of £.268 10 6, with six per cent. interest thereon from the 1st of November, 1792, in two equal annual payments; and that all legal process against them for the above sum shall cease immediately upon their executing a bond, with such security as the treasurer of the eastern shore shall approve, conditioned for the payment of the above sun
