cumstances similar to those of your petitioner. They are disposed to think, that if any case will justify a departure from the principle of its being requisite to obtain the assent of two thirds of the creditors in amount, the prefent petitioner's is one, but submit to the wisdom of the house the propriety of fuch discrimination.
