appertaining to tribunals already established and competent to afford redrefs. Your committee are of opinion that the party complaining ought to apply to the present orphans court of Worcester county for a revocation of the guardianship of his daughter, committed to another, and to be appointed himself her guardian; and that if such application be dismissed, he may have his remedy by an appeal either to the general or chancery court. With respect to the second object of the petition of the memorialist, namely, that the legislature should inquire, whether there has not been gross corruption and partiality in the members, or some of them, of the aforesaid orphans court, in making the faid appointment of guardian to the daughter of the petitioner. your committee state, that no proof of corruption or partiality in the said court, or any of its members, has been offered to them, and are rather of opinion that if proof ever so flagrant was offered, the punishment of the court, or any of its members, ought, in strictness, to be referred to the existing judiciary tribunals. Then, on both points, your committee are of opinion, that this house ought not to interfere, and recommend that the prayer of the petitioner should be dismissed.
