BY THE HOUSE OF DELEGATES, DECEMBER 15, 1800.

GENTLEMEN OF THE SENATE,

WE have fent you back the bill, entitled, A supplement to the act for the promotion of literature in this state, for reconsideration; it contains provisions of great and serious importance, as it is predicated upon the unequivocal principle of promoting and diffeminating uleful knowledge. The delegation from the counties to which the bill extends, have but one opinion upon the propriety, the ulefulness and preference of two seminaries, as contemplated by the bill, instead of one on the principle of the act passed in 1798. And they have no hesitation in making declaration, that their fentiments on this subject will be approbated by their constituents. It is hoped, that as the plan proposed by the bill is thus strongly recommended, that the opinion of those who represent Baltimore and Harford counties, which are mentioned in the bill, will have its due weight with the senate, and upon reconsideration of the subject, the bill may pass.
