Whereupon Resolved, That Francis Digges, Allen B. Duckett, Reverdy Ghiselin, Edward Hall and David-

fon David, Esquires, be, and they are hereby declared to be, the council to the governor.

Mr. Purnell, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the account of the register of the land-office for the western shore report, that having examined his account and vouchers, they find, that between the fecond day of January eighteen hundred and one, and the fecond day of October, of the same year, he has received twenty-nine pounds five shillings current money for taxes proceedings in the land-office, and that he has regularly accounted for and paid over the fame, to the treasurer of the western shore, first deducting his commission therefrom, amount ing to the fum of one pound three flillings and four-pence and four-fifths current money.
