

On motion, Leave given to bring in a bill, entitled, An act to alter the times of the session of Baltimore county court, of the court of oyer and terminer and gaol delivery for Baltimore county, and of the court of appeals. ORDERED, That Mr. Scott, Mr. Dickson, Mr. Moore, Mr. Stansbury and Mr. Mackall, be a committee to prepare and bring in the same.

A petition from sundry inhabitants of Montgomery county, praying an act may pass for opening a road from John Orme's plantation to Montgomery court-house, was preferred, read, and referred to Mr. Magruder, Mr. T. Davis and Mr. Swearingen, to consider and report thereon.

A petition from sundry inhabitants of Washington county, praying an act may pass for laying off and opening a road on the nearest and best ground from Elizabeth-town, by Barnett's fording, on Conococheague, to the state line, so as to meet the road already laid out from Mercersburgh to the state line in Pennsylvania, was preferred, read, and referred to Mr. Ott, Mr. Tilghman, Mr. Cresap, Mr. Shriver and Mr. Kemp, to consider and report thereon.

The clerk of the senate delivers the bill for the benefit of Benjamin Ward, of Prince-George's county, endorsed; "By the senate, November 11, 1801: Read the first time and ordered to lie on the table.

A petition from sundry inhabitants of Washington county, counter to the petition of sundry inhabitants of said county respecting a road from Elizabeth-town to Mercersburgh, in Pennsylvania, was preferred, read, and referred to the committee appointed on the petition to which it is counter.

A petition from sundry inhabitants of Washington county, praying commissioners may be appointed to lay out a road to intersect the road leading from Elizabeth-town to the Island Ford, was preferred, read, and referred to Mr. Cresap, Mr. Tilghman, Mr. T. Davis, Mr. Cellar and Mr. Smith, to consider and report thereon.

A petition from Nathan Robinet and Moses Robinet, of Allegany county, praying an act may pass authorizing the several clerks to correct an error in a deed made between the petitioners, was preferred, read, and referred to Mr. B. Tomlinson, Mr. Van-Horn and Mr. Simkins, to consider and report thereon.
