A petition from John Dames, and others, securities of Henry Costin, late sherisf of Queen-Anne's county, praying they may be authorifed to collect the balances due the faid sheriff, and vesting in them a property in the fees, accounts, and all other papers relating to the office of the faid sheriff, was preferred, read, and referred to Mr. Lowrey, Mr. Montgomery and Mr. Scott, to confider and report thereon.

Mr. Cresap, from the committee, delivers to the speaker a bill, entitled, An act to incorporate a company for establishing a turnpike road from the burnt mill, about one mile below the mouth of George's creek, on the Pasowmack river, to the nearest western navigation; which was read the first time and ordered to lie on the table.
