On motion, Leave given to bring in a bill to regulate the fees of the county clerks in this state. ORDERED, That Mr. Ridgely, Mr. Chapman and Mr. Montgomery, be a committee to prepare and bring in the same.

Mr. Handy, from the committee, delivers to the speaker a bill, entitled, An act to incorporate the presbyterian church at Pitt's creek hundred, in Worcester county; which was read the first time and ordered to lie on the table.

The resolutions respecting William Richardson, junior, treasurer of the eastern shore, were read the second time, agreeably to the order of the day, and the question put, That the same be committed for amendment? Resolved in the affirmative.

On motion, ORDERED, That Mr. Montgomery, Mr. Scott, Mr. Ridgely, Mr. Wood and Mr. Van-Horn, be a committee to report amendments to the same.

The clerk of the senate delivers the resolution in favour of William Gardiner, endorsed; "By the senate, November 19, 1801: Read the first time and ordered to lie on the table.
