

VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1801.

On the second reading of the bill to provide for the collecting of duties or tolls on merchandise and other articles carried out of, or brought into, this state, on the bed of the river Susquehanna, and augmenting the number of canal shares, agreeably to the order of the day, the question was put, That the following section be stricken out? "Be it enacted, by the general assembly of Maryland, That there shall be paid on all merchandise and other articles carried on the bed of the river Susquehanna, between tide-water and the line of this state, to the governor and directors of the Susquehanna canal, or to such person or persons at the said canal, or at Hayre-de-Grace, as shall be authorized by them to receive the same, one half of the said toll or duty which such merchandise or other articles would be liable to pay for passing through the said canal; and the person who shall receive the said toll or duty shall give a receipt, expressing the amount, and on what account, and of whom the same was so received, and the producing the said receipt, signed by such receiver or collector of tolls, shall be a sufficient justification to any person or persons who shall purchase or receive the said merchandise or other articles."
