THE committee to whom was referred the petition of Robert Long, of Baltimore county, report, that they have taken the same under their consideration, and find the facts therein stated to be true; they therefore recommend the following refolutions:

RESOLVED, That the committee of claims be directed to allow to Robert Long, on the journal of accounts, the sum of fixty dollars as a compensation for the support and maintenance of negro Daniel, the property of the

Rate, for the year eighteen hundred and one.

RESOLVED, That the treasurer of the western shore shall and he is hereby authorised and directed to pay, out of any unappropriated money, the sum of fixty dollars per annum to the said Robert Long, or his order, in half yearly payments, for and during the life of the faid negro Daniel, provided the faid Robert Long shall conti-

nue to reside in this state, and support and maintain the said negro Daniel as heretosore.

RESOLVED, That if the faid Robert Long should remove out of the state during the life-time of the said negro Daniel, he the faid Robert Long shall, and he is hereby authorised and directed, previous to such removal, to contract with the trustees of the alms house of Baltimore county for the support and maintenance of the said negro Daniel, at the rate of fixty dollars per annum, and that on producing a certificate from the faid trustees of their having entered into such contract, and that they have received the faid Daniel into the alms-house aforesaid, the faid Robert Long shall be entitled to receive payment until the date of the said contract made with the trustees as aforefaid, and afterwards the said treasurer shall, and he is hereby directed, to pay to the order of the trustees aforesaid at the rate of fixty dollars per annum for and during the natural life of the said negro Daniel. RESOLVED, That the treasurer of the western shore pay to Philip Fischer, or order, the sum of £. 57 10 current money, out of any unappropriated money remaining in the treasury, after the payment of the journal of accounts, it being a balance due him from the state for his services as a foldier in the late German regiment.
