On motion, the question was put, That leave be given to bring in a bill to enable the court of appeals to continue certain causes? Determined in the negative.

Petitions from Clauding Besse, of the city of Baltimore, George Burroughs and John J. Sothoron, of Saint-Mary's county, and David Shippey, of Dorchester county, praying acts of insolvency, were preferred, read, and referred to the committee appointed on petitions of a similar nature.

A petition from Margaret Razer, of Frederick county, praying an act may pass enabling her to dispose of her fourth part of a tract of land, being part of Monocacy manor, was preferred, read, and referred to Mr. Nelson, Mr. Kershner and Mr. Kemp, to consider and report thereon.

Mr. Lowrey, from the committee of claims, delivers to the speaker the following report :

BY THE COMMITTEE OF CLAIMS.

YOUR committee beg leave to report, that they have examined the accounts and proceedings of Thomas Harwood, Esquire, treasurer of the western shore, and find, by an account settled by the committee of claims to the first day of November, 1801, there was a balance of 109,102 dollars 50 cents funded six per cent. stock, 77,777 dollars 91 cents deferred six per cent. stock, 258,799 dollars 69 cents funded three per cent. stock, and the sum of £. 16,664 11 10½ specie, remaining in the treasury.

That it appears to your committee, by the accounts of the said treasurer, he hath received, for escheats, caution, and improvements on land certificates, £. 2,774 6 1½. For confiscated property £. 1 0 6. Interest on funded six per cent. stock, 172 dollars 17 cents funded six per cent. stock, 101 dollars 74 cents deferred six per cent. stock, and the sum of £. 781 8 4 specie. For taxes under the act for establishing and securing the salary to the chancellor £. 1,064 16 2. For taxes under the act for the better administration of justice £. 1,435 15 10½. For taxes £. 532 14 10¼. For bonds taken for money and stock loaned £. 7,479 11 3. For bonds taken for vacant land in Allegany county £. 183 1 0. For bonds taken for Indian lands £. 1,575 0 2. For fines, forfeitures and americiaments, £. 1,404 13 4¼. For marriage licences £. 1,346 3 6. For ordinary, retailers, hawkers and pedlers licences, £. 3,192 4 8½. From the treasurer of the eastern shore £. 2,254 1 2½. From the governor and company of the Patowmack navigation for dividend on stock £. 457 17 6. From William Marbury, for a balance due from him on the auditor's books, £. 5,054 8 1. And from Benjamin Harwood, trustee, for dividends of interest and reimbursement on stock, £. 9,107 10 1.

That it appears to your committee the said treasurer hath received from the agent of the state, for taxes 704 dollars 42 cents funded six per cent. stock, and the sum of £. 234 0 7½ specie. For fines, forfeitures and americiaments, £. 178 13 0. For ordinary and retailers licences £. 1,199 15 6½. For taxes under the act for the better administration of justice £. 188 15 10½. For confiscated property £. 2,048 15 1. And for bonds taken for vacant land in Allegany county £. 601 14 10.

That it appears to your committee, by the accounts of the said treasurer, he hath paid the sum of £. 669 7 6 specie, agreeably to the resolutions of November session, 1797, in discharge of the emissions of June, 1780, which emissions your committee have counted and burnt.

That it also appears to your committee the said treasurer hath paid away from the first day of November, 1801, to the first day of November, 1802, the further sum of £. 34,262 17 6½ specie, for all which payments have been produced to your committee the necessary vouchers and receipts, and that there remains in the treasury the sum of 106,134 dollars 69 cents funded six per cent. stock, 76,252 dollars 99 cents deferred six per cent. stock, 258,799 dollars 69 cents funded three per cent. stock, and the sum of £. 24,827 14 0¼; which sum of specie is appropriated in the manner following, to wit :
