

# VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1802.

That your committee find, by the last report, there was the sum of £. 2,786 11 10 of the emissions of bills of credit made by an act of congress of the 18th of March, 1780, remaining in the treasury, paid in on account of British creditors; since that time the sum of £. 64 13 2, in said emissions, hath been received from the treasurer of the eastern shore, which two sums amount to £. 2,851 5 0.

That it appears to your committee, the treasurer hath paid away the sum of £. 350 0 0, for which payments have been produced to your committee the necessary vouchers and receipts, and that there still remains in the treasury the sum of £. 2,501 5 0.

A petition from Solomon Holms, of Dorchester county, praying an act may pass to make valid a deed from Mary Magdalene Vinson to John Vinson, deceased, was preferred, read, and referred to Mr. Steele, Mr. S. Frazier, Mr. Quynn, Mr. Nelson and Mr. Wilson, to consider and report thereon.

A petition from William Sprigg Bowie, of Prince-George's county, praying an act of insolvency, was preferred, read, and referred to Mr. Van-Horn, Mr. Chapman and Mr. Wood, to consider and report thereon.

A memorial from Jonathan Rutter, of Baltimore county, praying a sum of money paid into the treasury for part of a tract of land called Hanson's Wood, upon an escheat warrant, may be refunded him, was preferred, read, and referred to Mr. Stansbury, Mr. Montgomery and Mr. Purviance, to consider and report thereon.

A petition from William Summers, and others, of Caroline county, praying an act may pass to lop off so much of the road as leads from Peter Steal's, near the Three Bridges, until it intersects the main road leading from Peter Harris's to Potter's Landing, was preferred, read, and referred to Mr. Young, Mr. Orrell and Mr. Hardcastle, to consider and report thereon.

A petition from sundry inhabitants of Kent county, praying an act may pass laying out a road from a stone marked W. H. B. standing on the main road leading from the head of Sassafras to the head of Chester, and to run from thence through the lands of James Blackiston, and others, to the Delaware line, was preferred, read, and referred to Mr. Angier, Mr. A. Stuart and Mr. Frisby, to consider and report thereon.

On motion, Leave given to bring in a bill to direct the register of wills of Caroline county to keep his office in Denton, in the county aforesaid, and there to deposit all the books, papers and records, appertaining to his office. ORDERED, That Mr. Young, Mr. Hardcastle and Mr. Orrell, be a committee to prepare and bring in the same.

A petition from John Erskine, of Talbot county, praying an act of insolvency, was preferred, read, and referred to Mr. Martin, Mr. Nelson and Mr. Chapman, to consider and report thereon.

A petition from sundry inhabitants of the village of Denton, in Caroline county, praying an act may pass authorising certain commissioners to open a sufficient number of streets, lanes and alleys, in the village aforesaid, was preferred, read, and referred to Mr. Young, Mr. Hardcastle and Mr. Orrell, to consider and report thereon.

A petition from Philip Hardcastle, of Kent county, in the state of Delaware, praying an act may pass declaring the private road leading from his mills, as far as the road leading from Greensborough to parson Keene's, a public
