

VOTES AND PROCEEDINGS, NOVEMBER SESSION, 1802.

the real estate of John Wynn Harrison, one of the securities of the said deceased, was preferred, read, and referred to Mr. Lloyd, Mr. Rose and Mr. Martin, to consider and report thereon.

A petition from Nathaniel Talbot, of Caroline county, praying that an act may pass directing the damages and costs recovered against him by John Hardcastle, for opening a road agreeably to the order of the levy court of the county aforesaid, to be paid by the said county, was preferred, read, and referred to Mr. Young, Mr. Goldsborough and Mr. Orrell, to consider and report thereon.

The bill to lay out a road from William Sinclair's plantation to Vaughan's mine-run and Gunpowder mills, and from thence to the Owl-branch, was read the second time, passed, and sent to the senate by the clerk.

A petition from sundry inhabitants of Talbot county, praying that an act may pass authorising the levy court of said county to levy a sum of money on the inhabitants thereof for the purpose of amending the causeway in the said county so as to prevent them from being overflowed by the high tides, was preferred, read, and referred to Mr. Nabb, Mr. Martin and Mr. Lloyd, to consider and report thereon.

The supplement to an act, entitled, An act to regulate the inspection of tobacco, was read the second time, passed, and sent to the senate by the clerk.

Mr. Montgomery, from the committee, delivers to the speaker the following report :

THE committee to whom was referred the petition of Robert Amos, collector of Harford county, praying that he may be authorised and empowered to appoint a deputy to aid him in completing his collection, report, that the petitioner has already by law the power and authority prayed for, and that the further interference of the legislature is unnecessary.

Mr. Selby, from the committee, delivers to the speaker a bill, entitled, A supplement to an act, entitled, An act to erect a town in Montgomery county, and for other purposes; which was read the first time and ordered to lie on the table.

The bill for the benefit of John A. Gillison, of the city of Baltimore, was read the second time, passed, and sent to the senate by the clerk.

On motion, ORDERED, That the report of the committee of conference appointed to meet the committee of the Susquehanna canal company be withdrawn for amendment.

The clerk of the senate delivers a letter from his excellency the governor and council, enclosing an extract from a late letter of Mr. King relative to the bank stock of Maryland, endorsed; "By the senate, November 22, 1802: Read and referred to the consideration of the house of delegates.
