A petition from Thomas Hewitt, of Kent county, praying an act may pass to confirm his title to certain property in George-town, in Kent county, was preferred, read, and referred to Mr. A. Stuart, Mr. Angier and Mr. Martin, to consider and report thereon.

Mr. Dashiell, from the committee, delivers to the speaker a bill, entitled, An act to pay the civil list, and

other expences of civil government; which was read the first time and ordered to lie on the table.

On motion, Leave given to bring in a bill to repeal an acl, entitled, An act for the destruction of squirrels in Caroline county, passed at November session, 1800. ORDERED, That Mr. Young, Mr. Mitchell and Mr. Thompson, be a committee to prepare and bring in the same.

Mr. Goldsborough delivers to the speaker the following resolution:

Whereas it is represented to this general assembly, that a certain mulatto slave, called and known by the name of Peter White, who had for a considerable time been a general disburber of the peace and security of the good citizens of Queen-Anne's and other counties of this state, and whose outrages had excited such general terror as to induce the executive of this state to offer a considerable reward for apprehending him, was arrested in Caroline county, and at October term, eighteen hundred and one, was convicted in Caroline county court of a capital crime, committed by him in Somerset county, for which he was afterwards executed pursuant to his sentence: And whereas the sum of seventy-five pounds current money, the valuation of the said slave, has been paid by Caroline county to a certain Henry Carlton, of the state of Georgia, whose property he was at the time of his conviction; and the said county has also been subjected, in costs of prosecution and other necessary ex. pences relative to the said Peter White, to the payment of the further sum of £. 51 13 3 current money; therefore RESOLVED, That the treasurer of the eastern shore pay to the order of the levy court of Caroline county the sum of £. 126 13 3 current money, to be applied towards defraying the county charges of said county,

Which was read.

Mr. Dashiell, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of Philemon Charles Blake, of Queen-Anne's county, beg leave to report, that they have examined the same, and are of opinion that the prayer of the said petitioner, so far as relates to the collection of arrearages due him as sheriff of Queen-Anne's county, by execution, ought not to be granted; your committee are of opinion, that the prayer of the petitioner for an act of insolvency ought to be referred to the committee appointed on the petitions of insolvent debtors.
