The question was then put, That the following words be stricken out of the said clause? to wit: "and shall also be fined not less than fifty cents nor more than ten dollars, in the discretion of a company court-martial." Resolved in the affirmative.

On progression in reading the said bill, the question was put, That the forty-ninth clause of the said bill be stricken out? The yeas and nays being required, appeared as follow:

Resolved in the affirmative.

On further progression in reading the said bill, the question was put, That the adjutant-general be allowed the sum of six hundred dollars per annum? The yeas and nays being required, appeared as follow:
