On motion, Leave given to bring in a supplement to an act, entitled, An act to prevent excessive gaming. Ordered, That Mr. Chapman, Mr. Mercer and Mr. Goldsborough, be a committee to prepare and bring in the

same.

On motion, Leave given to bring in a supplement to an act, entitled, An act relating to the public roads in Queen-Anne's county. ORDERED, That Mr. Thompson, Mr. Sudler and Mr. Roberts, be a committee to prepare and bring in the same.

Mr. Lloyd, from the committee, delivers to the speaker a bill, entitled, An act for the relief of Samuel Nicholls, an insolvent debtor of Talbot county; which was read the first time and ordered to lie on the table.

Mr. Clarke, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of Mary Pepple, of Frederick county, praying that a law may pass divorcing her from her husband, Peter Pepple, report, that they had the same under consideration, and are of opinion that the facts therein stated are not sufficient to authorise the interference of the legislature, and recommend that the said Mary Pepple have leave to withdraw her petition.
