THE committee to whom was referred the report of the trustees of Washington academy, in Somerset county, beg leave to state, that they have examined the said report, and find that the academy is in a promising condition; that the trustees thereof have been vigilant and attentive; that the tutors are virtuous, moral men, and highly qualified to discharge the duties of their respective appointments; that your committee are of opinion, that Washington academy hath been extremely useful, not only to the county in which it is placed, but to many other counties of this state; that from the melancholy catastrophe of having the house burnt, they have been obliged to throw themselves on the legislature for their benevolent assistance; and your committee being of opinion that assistance ought to be afforded by the legislature to enable them to finish their new building, beg leave to submit the following resolution:

RESOLVED, That the treasurer of the western shore be, and he is hereby directed to loan to the trustees of the Washington academy, any sum not exceeding - dollars, the said trustees having first given such security as the treasurer shall approve, or a lien on the property of the said academy, for the repayment of the said sum, and legal interest thereon, provided no demand shall be made before the year eighteen hundred and six.

On motion, Leave given to bring in a bill to compel the registers of wills in the several counties therein mentioned to keep each his office at the seat of justice in the county for which he shall be register. ORDERED, That Mr. Chapman, Mr. Bayly, Mr. Montgomery, Mr. Shaaff and Mr. Goldsborough, be a committee to prepare and bring m the same.

Mr. Miller, from the committee, delivers to the speaker a bill, entitled, An act to authorise the levy court of Cacil county to lay out and open a road in said county; which was read the first time and ordered to lie on the table. The bill to declare a part of the old road leading from the mouth of Monocacy to George-town, in Montgo-

mery county, a public highway, was read the second time, and passed.

The clerk of the senate delivers the following resolution: BY THE SENATE, November 22, 1803.

RESOLVED, That in the election of a register of wills for Dorchester county, the person having a majority of the votes of all the attending members of both houses of the legislature, be recommended to the governor to be commissioned as register of wills for said county.
