to wit: " provided, that no slave or slaves for a term of years shall be subject to the above valuation, but the assessor or assessors shall value them in proportion to the time they have to serve, having reference always to the value of such slave for life." Determined in the negative.

The question was then put, That the said bill be recommitted for amendment? Determined in the negative, The bill being read throughout, the question was put, That the said bill do pass? Resolved in the affirmative.

Mr. Bayly, from the committee, delivers to the speaker a bill, entitled, An act to restrain the ill practices used by sheriffs in taking goods by fieri facias and selling them by venditioni exponas; which was read the first time and ordered to lie on the table.

Mr. Chapman has leave of absence for a few days.

The report on the petition of James Williams was read the second time, and the question put, That the house assent to the resolution therein contained? Resolved in the affirmative.

The house adjourns till to-morrow morning 9 o'clock.
