The report on the memorial of Samuel Norwood, and on the memorial of Edward Norwood, counter thereto, was read the second time, and, on motion, ORDERED, That the said report be withdrawn for amendment.

A petition, from John Worthington, of Anne-Arundel county, respecting the opening a road in Anne-Arundel and Prince-George's counties, was preferred and read.

Mr. Bayard, from the committee, delivers to the speaker a bill, entitled, An act for the destruction of wolves in Allegany county; which was read the first time and ordered to lie on the table.

Mr. Van-Horn, from the committee, delivers to the speaker the following report, as amended:

THE committee to whom was referred the memorial of Samuel Norwood, of Baltimore county, and the memorial of Edward Norwood, counter thereto, report, that they have taken the same under their consideration, and find the following facts: that on the fifth day of November, seventeen hundred and eighty-five, a written agreement was made between Edward Norwood and Samuel Norwood, wherein, among other things, it was agreed, that the profits of the ferry mentioned in the counter memorial should be equal; that in a bill filed by Edward Norwood against Samuel Norwood, it was decreed and adjudged, among other things, that the part of the agreement relating to the ferry, should be carried into effect; that an appeal from said decree of the chancery court was made, by Samuel Norwood, to the court of appeals, and thereupon the court of appeals affirmed, among other things, that part of the decree aforesaid which related to the said ferry; that the land adjoining to said ferry, on which the said bridge is designed to be built, is the property of Samuel Norwood; that the said bridge, if built, will interfere with the joint interest in the ferry. Your committee further report, that in their opinion the building of a bridge at the place proposed by the petitioner, would be highly advantageous to the public, and in order that the opinion of the house may be taken on the above statement of facts, your committee submit the following resolution:

RESOLVED, That leave be given to bring in a bill to authorise the building of a toll bridge over the river Patapsco at or near Norwood's ferry.
