HE house met. Present the same members as on yesterday. The proceedings of yesterday were read. The message and resolutions respecting the government-house were sent to the senate by the clerk.

Mr. Calvert, from the committee, delivers to the speaker a bill, entitled. An act empowering the chancellor to direct a sale of the real estate of Priscilla Howerton, late of Prince-George's county, deceased, for the purpose therein mentioned; which was read the first time and ordered to lie on the table.

Mr. Chapman, from the committee, delivers to the speaker a bill, entitled, An act for the benefit of Arthur

Thompson; which was read the first time and ordered to lie on the table.

Mr. Swearingen, from the committee, delivers to the speaker a bill, entitled, An act for the support of Elizabeth Oden and Elizabeth Randall, of Montgomery county; which was read the first and second time by especial order, passed, and sent to the senate by the clerk.

Petitions from Stephen Wilson and Edward Dennison, of Baltimore county, praying acts of insolvency,

were preferred and read.

The amendments to the bill for founding a college in the city or precincts of Baltimore, by the name of Bal-

timore College, were read the second time, agreed to, and the bill ordered to be engrossed.

Mr. Tomlinson, from the committee, delivers to the speaker a bill, entitled, An act to correct a mistake in the patent granted for lots number two thousand two hundred and one, two thousand two hundred and three, and two hundred and four, of the lands westward of Fort Cumberland; which was read the first and second time by especial order, passed, and sent to the senate by the clerk.

Mr. Swearingen, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of sundry inhabitants of Rockville, in Montgomery county, stating, that the road from George-town to Frederick-town runs through several lots in the upper square of said town, and praying that a law may pass authorising the levy court to alter and change the same, report, that they have taken the same into consideration, and find that the case is provided for by an act of assembly passed at November session, seventeen hundred and ninety-four; your committee are therefore of opinion that legislative interference is unnecessary.

Mr. Lloyd, from the committee, delivers to the speaker a bill, entitled, An act granting a loan of money to the trustees of the academy established in Easton, in Talbot county; which was read the first time and ordered

to lie on the table.

The bill for the encouragement of learning in Caroline county, was read the second time, and the question
