Bayard, are duly elected delegates for the said county, and Jesse Tomlinson is also returned as duly elected, but that it appears by the said return, that the said Upton Bruce had three hundred and thirty-seven votes, Benjamin Tomlinson three hundred and twenty-nine votes, John H. Bayard had three hundred and twenty votes, and Jesse Tomlinson three hundred votes; that John Simkins and George Rizer had three hundred and fifteen votes each, that Joseph Cresap had three hundred and fourteen votes, and Thomas Cresap had three hundred and eleven votes.
