A supplement to an act, entitled, An act to establish and regulate a market at Bridge-town, in Kent county, and for other purposes therein mentioned, the resolution in favour of William Ennalls, the resolution in favour of James Boarman, and the resolution in favour of Richard Watts, were sent to the senate by the clerk. The following message was read, agreed to, and sent to the senate by the clerk.

BY THE HOUSE OF DELEGATES, NOVEMBER 27, 1804.

GENTLEMEN OF THE SENATE,

WE agree to proceed immediately to the election of a person to be recommended to the governor as register of wills for Prince-George's county in the manner mentioned in your message of this morning.

By order,

The amendment proposed to the bill authorising Jacob Schnebely, late sheriff and collector of Washington county, to complete his collection, was read the second time, agreed to, and the bill ordered to be engrossed.

The house proceeded to ballot for a person to be recommended to the governor to be commissioned as register of wills for Prince-George's county; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after sometime returned and reported that Trueman Tyler was unanimously elected.

Whereupon RESOLVED, That Trueman Tyler be and he is hereby recommended to the governor to be com-

missioned as register of wills for Prince-George's county.

On motion, Leave given to bring in a bill to regulate and discipline the militia of this state, and to repeal the acts of assembly therein mentioned. ORDERED, That Mr. Stuart, Mr. Mercer, Mr. Stansbury, Mr. Montgomery, Mr. Clarke, Mr. Miller and Mr. Hatcheson, be a committee to prepare and bring in the same.

A petition from Andrew With, of Montgomery county, praying that a law may pass for his support as an out-pensioner, was preferred, read, and referred to Mr. Swearingen, Mr. Linthicum and Mr. Selby, to consi-

der and report thereon.

Mr. Bayard, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of William M. Mahon and George Thisle, in behalf of themselves and others, securities of Robert Sinclair, report, that they have taken the same under their consideration, and find the facts therein stated to be true, and are of opinion that the relief prayed for ought to be

granted; they therefore submit the following resolution:

RESOLVED, That such of the securities of Robert Sinclair, late sheriff of Allegany county, as have discharged their proportion of the principal and interest on the judgments obtained against them in the general court, on or before the fifth day of November instant, shall be and they are hereby released from the payment of nine per cent. interest incurred by the non-payment of the same before the first day of November instant, according to resolutions passed at last session; and such of the said securities as shall pay into the treasury their respective proportions of principal and interest on said judgments at or before the end of the present session of the general assembly, shall be and they are hereby released from the payment of said nine per cent. incurred by a non-compliance with said resolutions passed last session of assembly.

Which was read the first and second time, the resolution therein contained assented to, and sent to the se-

nate by the clerk.

On motion, Leave given to bring in a bill directing the manner of taking depositions in the cases therein mentioned. Ondened, That Mr. Montgomery, Mr. J. Bayly, Mr. Stephen, Mr. Clarke and Mr. Cottman, be a committee to prepare and bring in the same.

The following resolution was read the first and second time and assented to.

RESOLVED, That the governor and council be and they are hereby requested to transmit to this house the following letters on the subject of the bank stock in England, to wit: A letter from Samuel Chase to the governor, dated March 22d, 1802, from same to same dated February 13th, 1802, from same to same dated December 24th, 1802, from William Pinkney to the secretary of state of the United States, dated October 22d, 1803, from same to the governor dated September 20th, 1803.

A petition from sundry inhabitants of Queen-Anne's county, praying that certain roads therein mentioned in said county may be declared public highways, was preferred, read, and referred to Mr. Thompson, Mr. Lowrey

and Mr. Blake, to consider and report thereon.

A petition from sundry inhabitants of Queen-Anne's county, praying that an act may pass to lay out a road from doctor Whittington's gate, on the Church Hill road, to lead through Double creek to the lower red lion mill, and thence to the public road leading towards the head of Chester, was preferred, read, and referred to Mr. Thompson, Mr. Lowrey and Mr. Blake, to consider and report thereon.

Mr. J. Bayly, from the committee, delivers to the speaker a bill, entitled, An act for the benefit of Joyce

Insley, of Dorchester county; which was read the first time and ordered to lie on the table.

A petition from John Dames, and others, of Queen-Anne's county, praying that time may be granted them to discharge certain judgments obtained against them by the state, as securities of Henry Costin, late sheriff of Queen-Anne's county, was preferred, read, and referred to Mr. Thompson, Mr. Montgomery, Mr. Lowrey, Mr. Blake and Mr. Hatcheson, to consider and report thereon.

On motion, Leave given to bring in a bill to authorise and provide for the purchase of books, and the establishment of a library, for the use of the legislature of Maryland. ORDERED, That Mr. Parnham, Mr. Mer-

cer, Mr. Thomas, Mr. J. Bayly and Mr. Cottman, be a committee to prepare and bring in the same.
