Mr. Chapman, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of Rebecca Stuart, of the city of Bakimare, report, that they have considered the subject matter of the said petition, and are satisfied, from the most ample testimony, that the petitioner's daughter, the daughter of captain Richard Dorsey, deceased, who was a meritorism officer in the revolutionary war, is unfortunately bereft of her reason, and also deprived of the use of her limbs, in such manner as to render her incapable of making any exertions for a livelihood, that her friends are not in a situation to afford her that assistance indispensable to her support. Your committee, believing that the legislature of Maryland will ever view with an eye of pity and commiseration the sufferings of a child of a man who signalized himself in defence of American liberty, and that they will never permit the offspring of such a character to feel the pinching hand of poverty, or the bitterness of affliction, which can be obviated by a small pecuniary aid, recommend the following resolution:

RESOLVED, That the treasurer of the western shore pay to Clement Skerrett, of the city of Baltimore, for the use of Mary Dorsey, daughter of captain Richard Dorsey, deceased, late an officer in the revolutionary war, the sum of —— dollars annually, in half yearly payments, to be applied towards her support and maintenance, during the life of the said Mary Dorsey, and in case of the death of the said Clement Skerrett, to such person, for the uses aforesaid, as the orphans court of Baltimore county may appoint, on behalf of the said Mary Dorsey.

A petition from sundry inhabitants of Chester-town and Kent county, praying that a company may be incorporated for the purpose of building a drawbridge across Chester river, was preferred, read, and referred to Mr. Scott, Mr. Moore, Mr. Hatcheson, Mr. Lowrey and Mr. Thompson, to consider and report thereon.

The following resolutions being propounded to the house, were read.

RESOLVED, That William Pinkney, Esquire, eminently merits the unqualified approbation of this legislature for his ability, zeal and honourable conduct, in effecting the transfer of stock and dividends belonging to the state of Maryland in the British funds, in pursuance of instructions from the president of the United States and the executive of Maryland.

RESOLVED, That the state of Maryland, as an acknowledgment of the high sense it entertains of the signal services of the said William Pinkney, Esquire, in ably conducting this long retarded, weighty and difficult business to a successful issue, and as a liberal remuneration for the time, talents and exertions, devoted by him in promoting, thus eminently, its great and important interests, frankly presents to the said William Pinkney, Esquire, and he is hereby allowed, out of the said stock, to the smount of —— pounds, and the minister of the United States resident at the court of St. James's, in whose name the said stock is now held for the use of the state, is hereby requested to transfer stock to the said William Pinkney, Esquire, or to his order, to the amount aforesaid.

RESOLVED, That the governor be and he is hereby requested to transmit to William Pinkney, Esquire, a co-

py of the aforegoing resolutions.

ORDERED, That the printer to the state strike one hundred copies of the said resolutions for the use of the

general assembly.
