clusion, that he acted the part of a brave and faithful officer, and that while thus engaged in his country's cause,

he was dangerously wounded, and remains to this day injured and disabled.

Your committee are therefore decidedly of opinion, that said Fickle justly merits the reward he claims, and that having spent the best part of his life in defence of his country, now that he is old and destitute that country cannot do less than render to his pretensions that consideration they merit.

Your committee therefore recommend the adoption of the following resolution:

RESOLVED, That the treasurer of the western shore be and he is hereby directed and required to pay unto Benjamin Fickle, of the state of Ohio, late a lieutenant in the revolutionary war, a sum of money equal to half pay as lieutenant, annually, in quarterly payments, during his life, as a further reward to those meritorious services which he rendered his country in establishing her liberty and independence.
