

ORDERED, That the bill, entitled, An act to incorporate a company to make a turnpike road to lead from the cross roads near Richard Caton's limekiln, in Baltimore county, nearly in the direction of Jones's Falls to the city of Baltimore, be read the second time on Monday next.

ORDERED, That the bill, entitled, An act to regulate and discipline the militia of this state, be read the second time on Wednesday next.

On motion, the question was put, Shall leave be given to bring in a bill to authorise the levy court of Baltimore county to keep in repair the road leading into Pratt-street, in the city of Baltimore? Resolved in the affirmative. ORDERED, That Mr. Ellicott, Mr. Stansbury and Mr. Harryman, be a committee to prepare and bring in the same.

On motion, Leave given to bring in a bill, entitled, An additional supplement to an act to streighten and amend the public roads in Harford county, and to repeal the third section of the act of assembly therein mentioned. ORDERED, That Mr. Montgomery, Mr. Ayres and Mr. Stansbury, be a committee to prepare and bring in the same.

ORDERED, That the printer to the state strike one hundred copies of the address from the visitors and governors of St. John's college, for the use of the general assembly.

The house adjourns until to-morrow morning 9 o'clock.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Williams has leave of absence for the remainder of the session.

Petitions from Benjamin Willmot, of Talbot county, and Abraham Jarrett, of Harford county, praying acts of insolvency, were preferred, read, and referred to the committee appointed on petitions of a similar nature.

A petition from John B. Beall, of Allegany county, praying further time to enable him to pay the balance of a debt due from him to the state, was preferred, read, and referred to Mr. Bayard, Mr. Bruce, and Mr. B. Tomlinson, to consider and report thereon.

A petition from sundry inhabitants of Harford county, praying that a law may not pass to open a road from a place called Sandy Bottom, on the road leading from Coop-town to Belle-Air, to intersect the road leading from Hanaway's mill to the Rock Ford, on the Little Falls, was preferred, read, and referred to the committee appointed on the petition to which it is counter.

Mr. Contee, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of John Smith Brookes, of Prince-George's county, report, that they have taken the same into consideration, and are of opinion that the prayer of the petitioner ought to be granted; they therefore submit the following resolution:

RESOLVED, That all proceedings be stayed on a judgment obtained against John Smith Brookes, of Prince-George's county, at the suit of the state, until the — day of — next, on his paying up all the interest due thereon; provided, that nothing herein contained shall preclude the state from issuing any execution on the said judgment, within twelve months after the expiration of the said stay, for the recovery of such sum or sums of money as shall or may be due thereon.
