The bill, entitled, An act for the benefit of Andrew Hamilton, of Prince-George's county, the bill, entitled, An act to authorise the justices of the levy court of Washington county to assess a sum of money on the taxable property of said county for the purposes therein mentioned, and the bill, entitled, An act authorising James Hackett, and others, securities of James R. Pratt, late sheriff, and John B. Hackett and Richard E. Harrison, late collectors, of Queen-Anne's county, to complete the collection of the money due the said sheriff and collectors, were read the second time, passed, and sent to the senate by the clerk.

A petition from sundry inhabitants of Somerset county, praying a law may pass to authorise the levy court of said county to levy a sum of money to complete a road, to begin at the corner of John Killium's fence, and running through the lands of Isaac Read and William Wilson, until it intersects the county road at the corner of Samuel Read's fence, was preferred, read, and referred to Mr. Bayly, Mr. Hyland and Mr. Jackson, to consider and report thereon.

The bill, entitled, An act for the benefit of Amelia Chance, of Caroline county, was read the second time, passed, and sent to the senate by the clerk.

The house resumed the consideration of the bill, entitled, An act to confirm an act, entitled, An act to provide for the trial of facts in the several counties of this state, and to alter, change and abolish, all such parts of the constitution and form of government as relate to the general court and court of appeals, and, after sometime being spent in debating the same, the order of the day for investing money in the Farmers Bank of Maryland was postponed until to-morrow.
