"Whereas the state hath heretofore become a stockholder in the Bank of Baltimore to the amount of one hundred and six thousand two hundred dollars, in the Union Bank of Maryland to the amount of forty-two thousand four hundred dollars, and in the Farmers Bank of Maryland to the amount of forty thousand dollars: And whereas it is intended to vest in stock of the said banks the further sum of three hundred and eleven thousand three hundred dollars, and this general assembly, always solicitous to cherish and protect the interest of the farmers, planters and mechanics, as well as to promote the interest of the commercial part of the citizens." Resolved in the affirmative.

On motion, the question was put, That the following be inserted after the said amendment? "Convinced that the Farmers Bank of Maryland, being established for the benefit of the farmers, planters and mechanics of our country, merits, and ought to receive from the state, a patronage equal at least to that afforded to any other bank."
