Mr. Bruce, from the committee, delivers to the speaker a bill, entitled, A supplement to an act to reduce into one the several acts of assembly respecting elections, and to regulate said elections; which was read the first time and ordered to lie on the table.

THE house met. Present the same members as on yesterday. The proceedings of yesterday were read.

The additional supplement to an act, entitled, An act to erect Baltimore-town, in Baltimore county, into a city, and to incorporate the inhabitants thereof, the bill relating to the inspection of tobacco not the growth of this state, and the resolutions relative to the bank stock of this state, were sent to the senate by the clerk.

The bill to appoint commissioners for the regulation and improvement of Chester-town, in Kent county, and for other purposes, was read the second time, passed, and sent to the senate by the clerk.

The clerk of the senate delivers the bill to establish a chancery tribunal on the eastern shore of this state, and to alter and abolish all such parts of the constitution and form of government of this state as are repugnant thereto, and the supplement to an act to establish a bank, and incorporate a company, under the name of The Farmers Bank of Maryland, and for other purposes, severally endorsed, "will not pass."
