So it was resolved in the affirmative.

The engrossed bills Nos. 110, 114, 117, 118 and 119, were read and assented to, and, with the paper bills

thereof, sent to the senate by the clerk.

On motion, ORDERED, That the supplement to the act, entitled, An act relating to negroes, and to repeal the acts of assembly therein mentioned, and the bill to open, improve and turnpike, the road leading from Wil. liam's Port, in Washington county, to Cumberland, in Allegany county, be referred to the consideration of the next general assembly.

The amendments proposed to the further additional supplement to the act, entitled, An act to direct descents,

were read the second time, agreed to, and the bill ordered to be engrossed.

The clerk of the senate delivers the engrossed bills Nos. 110, 114, 117, 118 and 119, with the paper bills thereof, severally endorsed, " read and assented to."

The following resolution was read the first and second time by especial order, assented to, and sent to the

senate by the clerk.

RESOLVED, That the treasurer of the eastern shore pay to the examiner of the said shore the sum of one hundred and thirty-three pounds seven shillings and ten-pence three farthings, to complete his salary for the year

eighteen hundred and five.

The clerk of the senate delivers the resolutions relative to certain bills of exchange, the resolutions in fayour of Martha Raisin and Henry Gassaway, and the resolution relative to Saint-John's and Washington colleges, severally endorsed, "dissented from." And the resolution in favour of Thomas Bayly and John Cottman, endorsed, "assented to." Love, Levi Hollingsworth, Daniel Conn, Samuel Sterrett and George Warner, commissioners appointed to su perintend the erection of a penitentiary, or to their order, or the order of a majority of them, the sum of twenty thousand dollars, to be applied to that object, as the same shall come into the treasury from the fines forfeitures, licences and amerciaments, arising within the city and county of Baltimore.
