in Baltimore county, was read the second time, passed, and sent to the senate by the cierk.

The bill supplementary to an act, entitled, An act to incorporate the stockholders in the Union Bank of Maryland, was read the second time, and the question put, Shail the said bill pass? Resolved in the affirmative; which was sent to the senate by the clerk.

Mr. Chapman, from the committee, delivers to the speaker the following report:

THE committee to whom was referred the petition of John Boudy report, that they have considered the same, and find, that the petitioner has served as a soldier in the Maryland line during the revolutionary war, as stated in his petition; that he is far advanced in the wane of life, and extremely indigent; your committee, believing that from the services rendered his country, his advanced age, and extreme poverty, he is an object worthy of legislative protection; they therefore recommend the following resolution:

RESOLVED, That the treasurer of the western shore pay to John Boudy, late a soldier in the Maryland limeduring the revolutionary war, a sum of money annually, in half yearly payments, equal to the half pay of a

soldier when in the army of the United States.
