Stansbury, major Thomas Talbot, Moses Brown, George Luckett, doctor Hugh Whiteford, doctor Jacob Hall, Elijah Davis and John Moore, shall be and they are hereby appointed trustees for the purpose of ipcating erecling and superintending, the academy aforesaid, and it shall be lawful for them, or a majority of them, so soon as the said academy shall be fit for the reception of scholars, to draw on the treasurer of the western shore for the sum of eight hundred dollars annually, for the payment of the teacher or teachers of said arademy; and the majority of the trustees hereby appointed shall be competent to perform any or all the du-
