The resolutions relative to the Farmers Bank, and the reso. lutions in favour of Robert C. Stone, and others, and John S. Brookes, severally endorsed "dissented from," The resolution relative to the address to the president, and the resolution in favour of Charles Gordon, John Trippe and John Davis, severally endorsed "unanimously assented to." And the resolution in favour of Wil. liam Taylor, endorsed " assented to." Also the following message:
