Mr. Sedler, from the committee, delivers to the speaker the said bill; which was read the first and second

time by especial order, passed, and sent to the senate by the clerk.

The clerk of the senate delivers the resolution relative to forwarding the militia law to each member, the resolution in favour of John Sullivan, messenger to the court of chancery, the resolution in favour of Frederick and Samuel Green, severally endorsed, "assented to." The resolution in favour of Bennett Hamilton and Charles Sewell, endorsed, "assented to with the proposed amendment;" which amendment was read and assented to. The resolution in favour of John Kilty, Esquire, endorsed, "dissented from." And the following message:

RESOLVED, That John Sprigg Belt and David Kerr, junior, be directors in the Farmers Bank of Maryland, That Tobias E. Stansbury and Peter Little be directors in the Mechanics Bank of Baltimore, and that John

Bowles be a director in the Hagar's-town Bank, on the part of this state, for the ensuing year.

The engrossed bills from No. 85 to 152, inclusive, were read, assented to, and, with the paper bills thereof,

sent to the senate by the clerk.
