woolles clothes or cotton clothes, or cotton shirting or linea shirting, if, in their opinion, the said company or companies shall be so organized as to promote these useful objects.

RESOLVED, That a bounty of ----- dollars shall be paid to any person or persons who may hereafter erect a manufactory or manufactories, provided it or they shall, in the opinion of the house of delegates, be eminently promotive of these objects, and conducive to the general welfare of the state-

manufactures of the country.

RESOLVED, That the aforegoing resolution be inserted in the journals of the house for the more general in-

spection of the citizens of this state.
