Mr. Tabbs delivers a petition from Catherine Hogmire, of Washington county, praying a divorce; which was read and referred to Mr. Tabbs, Mr. Worthington and Mr. Bowles, to consider and report thereon.

The bill to alter and change the names of Samuel, William and Jacob Cole, to Samuel, William and Jacob

Caple, was read the second time, passed, and sent to the senate by the clerk.

Mr. Palmer, from the committee, delivers a bill, entitled, An act annulling the marriage of Amelia Peters, of Queen-Anne's county; which was read the first time and ordered to lie on the table.

On motion, by Mr. Tabbs, the following resolution was read.

RESOLVED, That the court of Allegany county be and they are hereby authorised and required to contract with some person or persons, (taking bond with security for due performance,) for the expending of --- dollars, in such manner as the court shall direct, and to the best advantage, in opening and making passable the road already laid off and located, in the nearest direction from Hancock to Cumberland, which said sum the treasurer of the western shore is hereby directed and required to pay to the order or orders of the said court, out of any

The house having qualified agreeably to the constitution and form of government, proceeded to the choice of a governor, and the ballo's being deposited in the ballot box, the gentlemen named to strike retired, and after sometime returned and reported, that Edward Lloyd, Esquire, was elected.

Whereupon, RESOLVED, That Edward Lloyd, Esquire, be, and he is hereby declared to be, Governor of the state of Maryland.

Mr. Frazier, from the committee, delivers to the speaker a bill, entitled, An act to repeal the act, entitled, An act for the preservation of the navigation of Cabin creek, in Dorchester county; which was read the first time and ordered to lie on the table.

On motion, by Mr. Stevens, the following message was read, agreed to, and sent to the senate by the clerk. By the HOUSE of DELLGATES, November 13, 1809.

Gentlemen of the Senate,

THE honourable Edward Lloyd, Esquire, having been elected Governor of the state of Maryland, we have appointed Mr. Stevens and Mr. Chapman, jointly with such gentlemen as may be named by your house, to wait upon the governor elect and request his attendance in the senate room to qualify according to the constitution
