THE committee to whom was referred the petition of Vachel Burgess, of Anne-Arendel county, report, that they, from the documents herewith exhibitted, find, that the said petitioner entered into the service of his country early in the revolutionary war, that he was made an ensign in the 1st regiment of the Maryland line on April the 17th, 1777, and that he was sometime afterwards promoted to a lieutenancy, which commission he held until the 22d day of August, 1779. Your committee further report, that from the documents herewith exhibitted, it appears that the said Vachel Burgess was appointed a captain in the extra regiment raised in the year 1780, and served in that capacity until the said regiment was deranged: That during all this service he deported himself in a manner highly honourable to himself-and beneficial to his country, and well sustained the character of a true American patriot: That the said petitioner is now old and infirm, with a wife and nine children, who look to him for support, bending beneath a weight of years and infirmities, brought on him by hardships sustained by the labour and fatigue of several active campaigns while fighting the battles of his country, and with property too narrow to afford him and his helpless family the common comforts of life; your committee therefore recommend the following resolution:

RESOLVED, That the treasurer of the western shore be and he is hereby authorised and directed to pay to Vachel Burgess, of Anne-Arundel county, late a captain in the extra Maryland line during the revolutionary war, a sum of money equal to the half pay of a captain, during his life, as a further compensation for those in-

valuable services rendered his country while fighting for her liberties and securing her independence. By order. L. C. GASSAWAY, clk.
