

Mr. Baer delivers a bill, entitled, An act to widen a road in Frederick county, and a bill, entitled, An act to lay out a road in Frederick county; which were read the first time and ordered to lie on the table.
The house adjourns until Monday morning 9 o'clock.

MONDAY, November 27, 1809.

THE house met. Present the same members as on Saturday. The proceedings of Saturday were read. Mr. P. Spencer and Mr. Stevens appear in the house.

The bill to extend Aisquith-street in the city of Baltimore, was sent to the senate.
Mr. Ephraim K. Wilson, a delegate returned for Worcester county, appeared, and after qualifying in the mode prescribed by the constitution and form of government, and taking an oath to support the constitution of the United States, took his seat in the house.

The bill for the support of Matthew Bradburn, of Montgomery county, was read the second time, passed, and sent to the senate.

Mr. Worthington delivers petitions from Elizabeth Culberson and Susanna Beamer, of the city of Baltimore, praying to be divorced; which were read and referred to Mr. Worthington, Mr. Tabbs and Mr. Randall, to consider and report thereon.

The resolutions relative to weights and measures were read the second time, assented to, and sent to the senate.

Mr. Boyle delivers a petition from Henry Gassaway, of the city of Annapolis, a revolutionary officer; which was read and referred to the committee appointed on petitions of a similar nature.

Mr. Worthington delivers a petition from Moor Falls, and others, of the city of Baltimore, praying that the real estate of Stephen Wilson, deceased, may be sold for the benefit of his children; which was read and referred to Mr. Worthington, Mr. Bland and Mr. M. Brown, to consider and report thereon.

Also a petition from James Cocke, of the city of Baltimore, praying he may be authorised to hold slaves removed by him from the state of Virginia to Maryland; which was read and referred to Mr. Worthington, Mr. Tabbs and Mr. A. Dorsey, to consider and report thereon.

Mr. Stevens delivers a petition from James Doores, of Talbot county, praying a confirmation of his title to real property; which was read and referred to Mr. Stevens, Mr. Seth and Mr. P. Spencer, to consider and report thereon.

On motion by Mr. Boyle, Leave given to bring in a bill, entitled, An act to authorise a lottery for the repairing the protestant episcopal church in the city of Annapolis. ORDERED, That Mr. Boyle, Mr. Sands and Mr. Williams, be a committee to prepare and bring in the same.

Mr. Harryman delivers a petition from sundry inhabitants of Baltimore county, praying that the criminals may be employed in repairing the post-road from Baltimore to Philadelphia; which was read and referred to Mr. Harryman, Mr. M. Brown, Mr. Randall, Mr. Angier and Mr. J. S. Moffitt, to consider and report thereon.

Mr. Worthington delivers a petition from William Raborg and Mary Eislen, of the city of Baltimore, praying that part of the real estate of Conrad Eislen, deceased, may be sold; which was read and referred to Mr. Worthington, Mr. Winder and Mr. Bland, to consider and report thereon.

On motion by Mr. Streett, the question was put, That the bill to lay out and make public a road in Baltimore county therein mentioned, have a second reading on Thursday week? Determined in the negative.

On motion by Mr. Randall, the question was put, That the same have a second reading on to-morrow? Resolved in the affirmative.

On motion by Mr. J. Brown, Leave given to bring in a bill, entitled, An act to repeal and abolish the forty-fifth article of the constitution and form of government. ORDERED, That Mr. J. Brown, Mr. Chapman and Mr. Prideaux, be a committee to prepare and bring in the same.

The bill to lay out a road in Frederick county, was read the second time, passed, and sent to the senate.

The house proceeded to the second reading of the bill for the preservation and distribution of the vaccine matter for the use of the citizens of this state, and, on motion by Mr. Worthington, the question was put, That the 5th clause be stricken out? Resolved in the affirmative.

On motion by Mr. Worthington, the question was put, That the following be inserted in lieu thereof? "And be it enacted, That William Wilson, Robert Stewart, Luke Tiernan, Henry Schroeder, Simon Wilmer, Isaac Purnell, Samuel Harden, doctor John Cromwell, doctor William H. Glendenen, James W. Collins, John W. Glenn, Andrew Agnew, Alexander M-Donald, Edward Woodyear, Edward J. Coale and doctor James Smith, are appointed managers, and they, or a majority of them, may institute and establish a lottery or lotteries in the city of Baltimore, to raise a sum of money, not exceeding thirty thousand dollars, sufficient to procure a piece of ground, and to build thereon a convenient house for the aforesaid vaccine institution, for which said piece of ground, and the buildings which may be erected thereon, the said managers shall obtain a good and sufficient title, in fee-simple, to the state of Maryland, to be held for ever, as public property, for the purpose of a vaccine institution; provided, that before the managers, above appointed, proceed to the sale of any ticket or tickets in said lottery or lotteries, they, or a majority of them, shall give bond to the state of Maryland in the penalty of sixty thousand dollars, conditioned that they will well and truly apply the monies arising
