TUESDAY, November 28,

HE house met. Present the same members as on yesterday. The proceedings of yesterday were read. Mr. Davis delivers a bill, entitled, An act to empower the inhabitants of the town of Havre-de-Grace to elect the commissioners thereof; and Mr. J. Brown delivers a bill, entitled, An act to repeal and abolish the fortyfifth article of the constitution and form of government; which were read the first time and ordered to lie on the table.

Mr. Worthington delivers a petition from James Stuart, of the city of Baltimore, praying that the state may relinquish its title to lot No. 41 in said city; which was read and referred to Mr. Worthington, Mr. M. Brown,

Mr. Cottman, Mr. Randall and Mr. Boyle, to consider and report thereon.

Mr. Tabbs delivers a petition from sundry inhabitants of Washington county, praying for a public road from the Little Tonoloway Creek, at the ford near Hancock, to intersect a road leading from Bedford towards Hancock, at the Pennsylvania line, between Jeremiah Stilwell's and Samuel Graves's; which was read and referred to Mr. Tabbs, Mr. Bowles and Mr. Cellar, to consider and report thereon.

Mr. Groome delivers petitions from sundry inhabitants, recommending the taxing of bank stock for the educa-

tion of poor children; which were read and ordered to lie on the table.

On motion, by Mr. J. E. Spencer, the house resolved itself into a committee of the whole on the bill to lay out and make public a road in Baltimore county therein mentioned, Mr. Winder in the chair; and after sometime spent therein, the Speaker resumed the chair, and Mr. Winder reported the said bill with amendments.
