THE committee to whom was referred the petition of Samuel Norwood, and the petition of Edward Norwood counter thereto, report, that they have duly considered the same, and find that the said Edward Norwood and Samuel Norwood hold, as tenants in common, the interest in the ferry at which the petitioner, Samuel Norwood, prays to be authorised to build a bridge: That the said Samuel Norwood acknowledges it to be his design to build said bridge, if allowed, for his own benefit, to the exclusion of Edward Norwood, and by his petition offers to relinquish to the said Edward all the profits of the ferry aforesaid, in consideration of the privilege of building the bridge as aforesaid, to which the said Edward Norwood positively objects. Your committee further states, that it appears by a decree of the chancery court, recognizing a division of the land to which the said ferry is attached, among other things the ferry rights were ordered and adjudged to remain to the mutual benefit and interest of the said Messieurs Norwoods, which part of the aforesaid decree was affirmed by the court of appeals. Your committee are of opinion, to gratify the prayer of the petitioner, Samuel Norwood, would be an interference with private right, tending to destroy the interest of the counter petitioner in the aforesaid ferry, and in direct contravention of the decree of the court of chancery aforesaid, sanctioned by the court of appeals, which your committee conceive would be highly unjustifiable and improper, and therefore recommend that the petitioner, Samuel Norwood, have leave to withdraw his petition.
